Financial need is derived based on student or family income, household size and number in college. In this case, the Free Application for Federal Student Aid (FAFSA) generates the Expected Family Contribution (EFC) number, calculated by the methodology within an application. For determining the individual grant apportionment, our students' EFC will be incorporated as the first criteria of eligibility. The Department of Education considers zero (0) the most <u>need-based</u> EFC.
